CERTIFICATION

1. All sales by the Clearing Member of the shares of Bloomberry Resorts Corporation ("BLOOM") through the Philippine Stock Exchange ("PSE") which are cleared and settled through SCCP shall not be in violation of any order issued by Branch 66 of the Regional Trial Court of Makati City in SP. Proc. No. M-7567 entitled "Bloomberry Resorts and Hotels, Inc. et al vs. Global Gaming Philippines LLC, et al." which restrains the disposition of the 921,184,056 BLOOM shares ("Shares") that are beneficially owned by Global Gaming Philippines LLC;

2. The selling Clearing Member acknowledges and agrees that SCCP may, at its discretion, decline to clear and settle any trade of BLOOM shares by the Clearing Member in case the SCCP has reason to believe that the same include any of the Shares which are the subject of an order from the Court that restrains the disposition of the Shares, and the Clearing Member agrees to absolve and hold SCCP free and harmless from any and all costs, claims, suits, actions, liability, damages, fees and expenses of whatever nature that may be suffered or incurred by the Clearing Member as a result of SCCP's action, even if the sale by the Clearing Member of BLOOM shares is later determined not to include any of the Shares subject of the Court's order; and

3. In the event that the selling Clearing Member clears and settles through SCCP a trade involving any of the Shares, the selling Clearing Member undertakes to indemnify SCCP for, and hold SCCP free and harmless against, any and all costs, claims, suits, actions, liability, damages, fees and expenses of whatever nature that may be suffered or incurred by the SCCP, its directors, officers, employees and authorized representatives, as a result of, in relation to, or arising out of, the violation committed by the Clearing Member.
