The Philippine Stock Exchange, Inc. (PSE) has advised the recomposition of the PSEi in its Memorandum CN – No. 2022-0030, a copy of which is attached for your easy reference.

In line with our daily Mark-to-Market Collateral Deposit (MMCD) system, we wish to inform all Clearing Members who opt to submit securities that effective August 8, 2022 (Monday), SCCP will adopt the new composition of the PSEi as the issues that are eligible as collateral, subject to 20% haircut.

As previously approved by the SCCP Board, "PSE" shares continue to be eligible as collateral in addition to the thirty (30) listed companies comprising the revisited PSEi.
