The Philippine Stock Exchange, Inc. announced the changes to the, PSE DivY and PSE MidCap indices in their memorandum CN-No. 2024-0008 dated January 26, 2024.

There will be no change to the PSEi constituents.

In line with our daily Mark-to-Market Collateral Deposit (MMCD) system, we wish to inform all Clearing Members who opt to submit securities as collateral that effective February 05, 2024 (Monday), SCCP will adopt the PSEi and the new composition of the PSE DivY and PSE MidCap indices as the issues that are eligible as collateral. As previously approved by the SCCP Board, "PSE" shares will continue to be eligible as collateral.

Haircut percentage will also be applied as follows:

 $\begin{array}{lll} \text{PSEi} & -25\% \\ \text{MidCap Index} & -25\% \\ \text{Dividend Yield Index} & -25\% \\ \text{PSE Shares} & -35\% \end{array}$
