Subject : List of Securities Eligible as Collateral

The Philippine Stock Exchange, Inc. announced the results of the regular review of the PSEi, sector, PSE DivY and PSE MidCap indices in their memorandum CN-No. 2025-0005 dated January 24, 2025.

In line with our daily Mark-to-Market Collateral Deposit (MMCD) system, we wish to inform all Clearing Members who opt to submit securities as collateral that effective February 3, 2025 (Monday), SCCP will adopt the new composition of PSEi, PSE DivY index and PSE MidCap index as the issues that are eligible as collateral. As previously approved by the SCCP Board, "PSE" shares will continue to be eligible as collateral.
