The Philippine Stock Exchange, Inc. (PSE) has advised in its Memorandum CN - No. 2021-0008, a copy of which is attached for your easy reference, that there will be no changes in the PSE index (PSEi) based on the regular stock performance review for the period January to December 2020.

In line with our daily Mark-to-Market Collateral Deposit (MMCD) system, we wish to inform all Clearing Members who opt to submit securities as collateral for their negative exposures that there will be no change in the securities that are eligible as collateral, subject to a 20% haircut, until the next stock performance review by the Exchange.

As previously approved by the SCCP Board, "PSE" shares continue to be eligible as collateral in addition to the thirty (30) listed companies comprising the revisited PSEi.
