Subject: New Eligible Securities Collateral and Haircut Rates

Please be advised that on 13 December 2022, the Securities and Exchange Commission ("SEC") approved SCCP's proposed amendments to SCCP Rule 8.1.8 on Acceptable Collateral Deposits which provides that securities comprising the PSEi, the PSE MidCap Index, the PSE Dividend Yield Index and the PSE shares are eligible securities collateral in SCCP's Mark-to-Market Collateral Deposit ("MMCD") system.

Moreover, the securities collateral that belong to the PSEi shall be subject to a twenty five percent (25%) haircut based on their respective closing prices while the PSE shares shall be subject to a haircut of thirty five percent (35%) based on their closing price, to align the MMCD haircut rates with the position risk factors provided under the Capital Markets Integrity Corporation Rules and SEC Memorandum Circular No. 16, Series of 2004, Schedule A, in the computation of Clearing Members' Risk Based Capital Adequacy ratio.

The SEC has also approved SCCP's recommendation that the securities collateral belonging to the PSE MidCap Index and the PSE Dividend Yield Index be subject to a 25% haircut given that such securities have also met liquidity standards set by PSE and are therefore useful as collateral to cover price exposures in trading.

The above amendment to the SCCP Rules will provide more options to Clearing Members in terms of the availability of securities collateral that are considered liquid by a strict index review process regularly conducted by PSE.

To summarize, the new amendment to the SCCP Rules allows SCCP to accept securities collateral belonging to the PSEi, the PSE MidCap Index and the PSE Dividend Yield Index, as well as the PSE shares, subject to the following haircut rates:
