### PROCLAMATION NO. 425

# DECLARING TUESDAY, 26 DECEMBER 2023, AS A SPECIAL (NON-WORKING) DAY THROUGHOUT THE COUNTRY

WHEREAS, 25 December 2023 (Christmas Day) which is observed as a regular holiday throughout the country falls on a Monday;

WHEREAS, the declaration of 26 December 2023, Tuesday, as an additional special (non-working) day will give the people the full opportunity to celebrate the holiday with their families and loved ones;

**WHEREAS**, a longer weekend will encourage families to get together and strengthen their relationship leading to a better society;

WHEREAS, a longer weekend will also promote domestic tourism.

**NOW, THEREFORE, I, FERDINAND R. MARCOS, JR.**, President of the Philippines, by virtue of the powers vested in me by law, do hereby declare Tuesday, 26 December 2023, as a special (non-working) day throughout the country.

The Department of Labor and Employment is hereby directed to issue the appropriate circular to implement this Proclamation for the private sector.

**IN WITNESS WHEREOF**, I have hereunto set my hand and caused the seal of the Republic of the Philippines to be affixed.
