**PROCLAMATION NO. 839**

**DECLARING TUESDAY, 01 APRIL 2025, A REGULAR HOLIDAY THROUGHOUT THE COUNTRY IN OBSERVANCE OF *EID'L FITR* (FEAST OF RAMADHAN)**

**WHEREAS**, Republic Act No. 9177, amending Section 26, Chapter 7, Book I of Executive Order No. 292, declared *Eidul Fitr (Eid'l Fitr)* as a regular holiday throughout the country;

**WHEREAS**, the NCMF has recommended the declaration of 31 March 2025, (Monday), or 01 April 2025 (Tuesday) as a national holiday in observance of *Eid'l Fitr* (Feast of Ramadhan);

**WHEREAS**, in order to bring the religious and cultural significance of the *Eid'l Fitr* to the fore of national consciousness, and to allow the entire Filipino nation to join their Muslim brothers and sisters in peace and harmony in the observance and celebration of *Eid'l Fitr*, it is necessary to declare 01 April 2025, Tuesday, a regular holiday throughout the country.

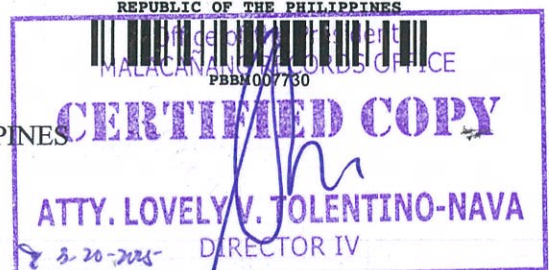
**NOW, THEREFORE, I, FERDINAND R. MARCOS, JR.**, President of the Philippines, by virtue of the powers vested in me by law, do hereby declare Tuesday, 01 April 2025, a regular holiday throughout the country in observance of *Eid'l Fitr* (Feast of Ramadhan).

**IN WITNESS WHEREOF**, I have hereunto set my hand and caused the seal of the Republic of the Philippines to be affixed.
