PROCLAMATION NO. 1189

DECLARING FRIDAY, 20 MARCH 2026, A REGULAR HOLIDAY THROUGHOUT THE COUNTRY IN OBSERVANCE OF EID'L FITR (FEAST OF RAMADHAN)

WHEREAS, Republic Act No. 9177, amending Section 26, Chapter 7, Book I of Executive Order No. 292, declared *Eidul Fitr (Eid'l Fitr)* as a regular holiday throughout the country;

WHEREAS, the National Commission on Muslim Filipinos has recommended the declaration of 20 March 2026, (Friday), or 21 March 2026 (Saturday) as a national holiday in observance of *Eid'l Fitr (Feast of Ramadhan)*;

WHEREAS, in order to bring the religious and cultural significance of the *Eid'l Fitr* to the fore of national consciousness, and to allow the entire Filipino nation to join their Muslim brothers and sisters in peace and harmony in the observance and celebration of *Eid'l Fitr*, it is necessary to declare 20 March 2026, Friday, a regular holiday throughout the country.

NOW, THEREFORE, I, FERDINAND R. MARCOS, JR., President of the Philippines, by virtue of the powers vested in me by law, do hereby declare Friday, 20 March 2026, a regular holiday throughout the country in observance of *Eid'l Fitr (Feast of Ramadhan)*.

IN WITNESS WHEREOF, I have hereunto set my hand and caused the seal of the Republic of the Philippines to be affixed.
